REPORTS:

a. Treasury Report (Jean):

The minutes from the last meeting show an Available Balance of \$7,379.53, which is the "Ending Balance". The "Available Balance" for the August (9-15-22) meeting minutes should read \$456. . Julie moves to approve the Treasurer's report from August with this change noted. Motion carries.

Lani suggested that the WCOC should have a working budget. Starting fresh with the January Membership meeting, the reserves from the two carry-over funds be incorporated with the Available Funds and a budget be created. The Financial Committee (Chaired by Jean Lam) to submit ideas for potential use of the funding in the Calendar Carry-over and Haunted Highway Funds. A discussion of the Budget should be on the agenda for the December Board Meeting. **b. Secretary's Report** (Chriss): Jean moves to approve the Minutes, Julie seconds, Motion carries.

Correspondence:

a. Lani has been getting correspondence intended for the Weaverville, N.C. organization. She responds appropriately.

b. There will be a discussion about the trees on Main Street on Sept. 29th at 9 am, in the Joss House Parking Lot. Nineteen trees need to be removed. Lani will push out this event on Facebook. This should be the responsibility of the County. Teckla mentioned that this is not a matter that the WCOC needs to respond to.

c. Teckla received a message that perhaps the WCOC could promote Beneficial Exercise, as is done with Shop Trinity, Shop Music, etc.

d. Chalk the Walk event on October 1st.

Unfinished Business

a. The meeting with Supervisor Cox was not what had been expected. The WCOC was thinking the meeting would be about Cannabis. Supervisor Cox discussed general County Economic

information. There will be quarterly meeting with Jill Cox in October. Teckla will send out the date and the agenda in advance so that Jill will know what we want to discuss. What is the direction that the WCOC wants to move in the issues of Cannabis vs. business development?

b. The Economic Pulse Survey will be sent to the BOS members. There will be a follow up on the poll next week to prepare for the Town Meeting, and there will be a discussion on the WCOC's stance on the Proposition L issue. Having the TOT go back to what it was intended for should be encouraged. We recognize what the question is, but perhaps at this time not taking an official position might be the best move.

New Business

a. Trinity County Chamber Update - Last meeting cancelled. Only 3 people showed up. **b. Marketing:** Scott did it all. As he is no longer a Board Member, the Marketing Committee will need to discuss potential people who could assist with our marketing needs. Two names were mentioned: Laura Seegmiller and Pete Keyes. Marketing Committee should take a look at the entire year -- what do we need to promote and who can do it? Jean to talk to Ron (After 5), Julie will talk with Jill R.

c. Board Member Search: Teckla will post that the WCOC has Board Member seats open. Need to start collecting names of potential new members.
